## TAX CLEARANCE CERTIFICATE FOR GRANT APPLICATIONS

As you know the 2020 grants round is now open.

To receive funding from the Local Authority **YOU MUST** have a **TAX CLEARANCE CERT** and be able to state this number on funding application forms.

The process is quite simple - just two pages of basic information.

As a brief overview of how to complete the form here are a few points we hope will help:

Section A1 simply asks for group name and contact information

Section A2 : Reason for seeking tax registration – here most groups will simply tick option 4. Application for Tax Clearance Certificate

Section A3: This should be a named position in the group – preferably the Chairperson

## Section A4

Q13 – this is just the main aim and activities of the group, ie a tidy towns group whose aim is to enhance the local area through

upkeep, preservation and protection of local biodiversity

Q14 – Here you simply state how you might gain sources of income, ie fundraising activities, subscriptions from members, grant aid

Q15 – This is about the group operation rather than individual projects that may employ someone so simply state 'no individual benefit'

Q16 – All that is needed here is 'Any funds will be directed to ongoing group activity'

Q17 - Sligo PPN are currently working with The Wheel to source clarification around this on your behalf. The advice at present is to ONLY select yes here at this stage if you are an existing recognised charity or sports club - therefore most member groups will leave this blank
