#### Empowerment through co-creating solutions ... ... Climate Conversations



- Climate Conversations articulated a public who are responsive and feel a sense of urgency around Climate Action.
- Enthusiasm to work with the government.
- Identified where people are making changes and where they feel they lack information, knowledge, resources, or capacity to do so.
- Asked for 'joined up thinking' and 'ambitious policies' to be reflected 'where they live'.
- It is clear that government and the public sector must lead by example, but delivering on this ambition is the responsibility of everyone in society.



# **Climate Conversations 2022**

The Climate Conversations have been designed to ensure reach to as broad and wide-ranging an audience as possible across the whole of Ireland.



Local and regional workshops with **Public Participation Network** (PPN) across Ireland



Interviews with senior stakeholders & **Subject Matter Experts** 



Focus groups with specific and hard to reach groups



Conduct one broad **online Public Consultation** on the climate action plan 2022; and



Conduct **one nationally representative online survey** (1 survey of 2000 adults).

# **PPN Objectives & Themes**



#### **Objective:**

- To build on last year's findings to track progress and identify regional barriers
- To understand what could drive further behavioural change amongst the population now and in the future

The PPN sessions are intended to be self-led, but the facilitators will be asked to consider the following themes and to try and ensure they are discussed throughout the conversation.





# **Key Discussion Points**

The following questions can be used as a guide for your discussion. However, we are very keen that this is participant-led and that they discuss whatever they feel is most relevant and important to them with reference to climate change.

- What factors are influencing your views on climate change?
- What consequences do you most associate with climate change?
- As an individual or as an organisation, do you know what you can do, what are you doing and what are you willing to do to address climate change?
- Have you or your organisation been impacted by climate change? How?
- What are your views on the Government's ambitions to reduce our carbon emissions by 50% by 2030 and make Ireland carbon neutral by 2050?
- What **policy areas** do you think the government should be focusing on to help combat climate change?
- What are the **barriers/challenges your community** faces when trying to act on climate change?
- What would you like the **Government to do to support you** to act?
- How could your Local Authority support you more in your efforts to tackle climate change?
- Where do you get your information on climate change?
- How do you think we could get more people involved in the debate about climate change and motivated to act?



## Suggested format of the session



We recommend the PPN session to last between **1.5-2 hours** 



The sessions can be hosted in person or virtually however we ask for you to **provide an online option** to allow for a representative from DECC to join to support



We recommend providing a **moderator** and **notetaker** to support in the facilitation of the session



We hope to keep this a **free-flowing conversation** and don't want to restrict topics, however we will provide you with prompted questions to guide the discussion



We recommend inviting **10-20 participants** from your community that you believe best represent the interests and demographics of your region.

#### <sup>01</sup> Report Template & Guiding Questions

We will provide a report template that is in a word doc. format to highlight and summarise the key themes and topics discussed in the session. Within the report we have included a list of questions that can be used to guide discussion.
